The agent or the vendor shall not be responsible for any deficiency or discrepancy in quality, quantity, weight and misdescription or merchantability of the Lot/s sold to the successful tenderers.
- 2 All tenderers are to submit their offer using the prescribed **Tender Sale Offer Form**.
- 3 The Tender Sale Offer Form must be completed correctly and returned to the Auctioneer, in a sealed envelope on or before **8 June 2021**, **4:00pm**, to 80 Changi Road #02-58, Centropod @ Changi, Singapore 419715
- 4 The Tender must be accompanied by a cashier's order or crossed cheque issued in favour of "AssetHub Pte Ltd" for a sum equivalent to 10% of the Total Tender Price (the "Deposit").
- 5 The Deposit shall be forfeited if the tenderer withdraws his tender for any reason whatsoever arising any time after the submission of the Tender Sale Offer Form.
